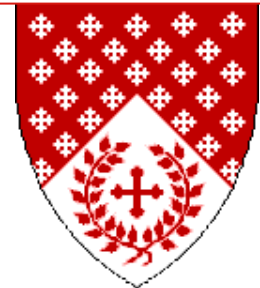
**Celtic Society Burns Night**
