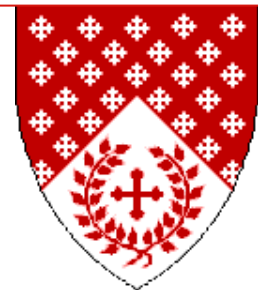

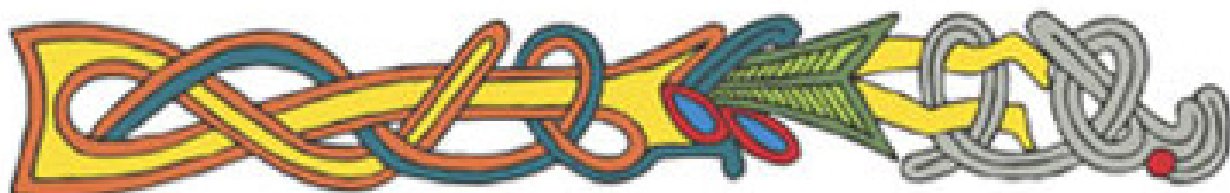
**Challenge of the Heart:** Storvik is not interested in having a joint event, as Novice Tourney is their one big event, they're known for and they'd like to keep it as theirs.

The financial committee meeting was held on Monday November 16<sup>th</sup> for the ADITME 2010 budget. Budget was worked on and approved.

A check was written to SCA Inc. for \$50 for the ADITME '10 insurance rider.

A check was written to the ADITME '10 site for \$462.50 which is the deposit and the first half of the site fees. Balance is to be paid two weeks prior to the event per the contract.

I will be attending Unevent this coming weekend in North Carolina.

The event report has been finalized for Birthday/Investiture '09. We had 73 adults attend (18 of which were non-members); and 5 children. We had an event profit of \$80.99
