Exchequer's Report

Our account balance is \$15,735.24

Camp Merrick has not cashed our check for Festival of Bones yet.

The refund checks and reimbursement checks for approved receipts from Festival of Bones have been signed and sent.

A few items of note from the UnEvent Exchequer's meeting -

1. When we order new checks, the new directive from Corporate is to have the name on all checks as "Barony of Dun Carraig, Society for Creative Anachronism, Maryland, Inc." I expressed concern about not being allowed to shorten to SCA-MD, Inc with the limited real estate on a check. Kingdom Exchequer will confirm with Corporate.
2. There was a suggestion to review signature cards yearly to make sure signatories are up to date. We have done this recently so there's no issue there.
3. Clarification - an event may comp a site owner the fee to come onto site during an event, but if they are not a member, they have to pay the NMR fee and sign a waiver to be on site. Question to that was "what about a grounds manager who needs to come on site and fix something?" Fjorleif will get clarity and get back to exchequers.

The rest of the updates were pretty exchequer report specific. If anyone has any questions, please reach out to me.

Note: Dun Carraig still needs to do a review of books because we have changed over Exchequers twice now without one. Mistress Lucina will help us with this.

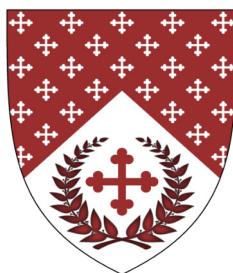

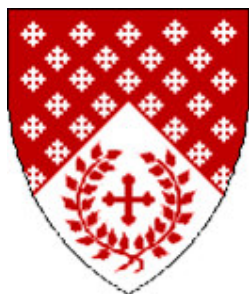
